THE ATLAS COMPLEXES AT FORBES AFB, SCHILLING AFB, KANSAS; LINCOLN

AFB AND OFFUTT AFB, NEBRASKA; AND THE TITAN COMPLEX AT MCCONNELL

AFB KANSAS. A SIMILAR COLLECTION EFFORT WAS ALLOWED LAST YEAR

AGAINST THESE AND OTHER STRATEGIC MISSILE INSTALLATIONS THE

VULNERABILITY OF OUR FORCE AND REACTION CAPABILITY THEREOF IS

FUNDAMENTAL TO SUCCESSFUL PLANNING AND EXECUTION OF THE SIOP.

THIS RECONNAISSANCE OF MISSILE SITES CAN ONLY BE USEFUL TO RUSSIA

AND SOVIET INITIATIVE ATTACK PLANNING. I STRONGLY RECOMMEND

THEREFORE THAT ALL U.S. MISSILE SITES BE CLASSED AS RESTRICTED
